Rules and Regulations 2026

Please read, sign and return with your registration form.

Markets are every Friday from 3:30pm to 6:30 pm from May 22nd to September 26th.

Note any Special event days- See Registration sheet for more information on Special events.

Market Fees- \$10.00 each market for a 10x 10 space.

Space Assignments- Time & Part-Time Vendors: You already have a vendor number and may proceed directly to your assigned space to set up.

- **Finding Your Space:** Vendors can call or text the Event Manager to confirm their space number
- **Guest Vendors:** Please check in with the Market Manager **one hour or more before the market opens.**
- **Assigned Spaces:** All vendors must sell within their assigned **10x10 space.** Selling outside of this space is not permitted.
- **Bigger Spaces:** If you need a larger space, contact the Event Manager **at least one week before the market.** Additional fees may apply.

Full/Part Time Vendors- Full and part-time vendors will receive priority when spaces are assigned. Please note that space assignments may change for special events.

Dates: Vendors are expected to attend all market dates they select. In the event of an emergency, please contact the event manager as soon as possible.

Set up/Breakdown-

Set-up begins at 1:00 PM on 3rd Street and must be completed by 3:20 PM. During this time, vehicles are allowed in the market area for unloading only. All vehicles must be removed from the street by 3:20 PM. Vendor parking is provided.

Breakdown. Vendors must remain set up and sell until 6:30 PM each market day. Beginning at 6:35 PM, vehicles may enter the market area for loading. If customers are still shopping at 6:35 PM, vendors are asked to remain courteous and wait until foot traffic has cleared before beginning breakdown.

Road Closed: 3rd Street will be blocked off for the market. Vendors may enter and exit during set-up time. You will have to move roadblocks to enter market, once 3:30 PM arrives, the street will be closed to all vehicles—no exceptions. Vendors arriving after that time must park and carry their items into the market.

No Early Tear Downs- After 3:30 PM, vendors are required to remain in their assigned space and sell until 6:30 PM—no exceptions. You may tidy your booth, but you must remain open. Vendors who leave early without prior approval from the event manager will not be placed in a middle-of-the-market location in the future and will instead be assigned a space closer to an exit to avoid disruption to customers and other vendors.

Canopies- All canopies must be securely tied down and properly anchored, with a minimum of 35 lbs. of weight on each leg. Weights and tie-downs must be attached in a way that does not create a hazard to customers or other vendors. Please note that the Elochoman Marina Street Market can be windy. If a canopy is deemed unsafe by the event manager, it will be required to be taken down immediately for the safety of everyone

Table, Displays and Signage- all tables and displays shall be in good condition and of adequate strength to support all products.

Vendor Parking- Contact event manager for parking instructions. Parking is available in the Marina parking area or grass area below the Old River mile 38 Brewery.

Special Requests- See the event manager prior to market to make any special requests regarding any market rules. Example, if you do sell out of a van or trailer. If you need to reschedule a market date, contact the event manager one week prior.

Cancelations/No shows-

Cancelations: Vendors must notify the event manager at least **one week in advance** if unable to attend on a date they signed up for. If payment has been made, **no refunds** will be issued. You may reschedule to another date.

No-Shows: If you sign up for a market and fail to notify the event manager, you will **lose your reserved space** and **will not receive a refund** for any paid market.

No Smoking - Smoking is **not permitted** at the Elochoman Marina Street Market.

Pets/Children Well-mannered pets on a **leash** are allowed, provided owners clean up after them. The market follows Cathlamet leash laws. Pick-up stations are available around the marina. Children must be **supervised at all times** during the market.

Disposing of Trash- Vendors are responsible for keeping their space clean and removing all trash at the end of the day. Dumpsters are provided for your use.
